THE MAJORITY OF OUR RESCUES WERE PREVIOUSLY OWNED PETS, USED IN THE ENTERTAINMENT INDUSTRY, OR SURRENDERED OR SEIZED FROM ROADSIDE ZOOS AND OTHER SUBSTANDARD FACILITIES. SAFE HAVEN HAS COMMITTED TO PROVIDING LIFELONG CARE TO 46 ANIMALS INCLUDING SEVERAL BIG CATS FROM AN INTERNATIONAL SEIZURE.
